

# 2024 Annual List of Project Obligations

Prepared by the Whatcom Council of Governments using funds contributed by member jurisdictions and grants from the Washington State Department of Transportation, the U.S. Department of Transportation Federal Highways and the Federal Transit Administration.

The Whatcom Council of Governments (WCOG) annual list of project obligations for 2024 demonstrates the implementation of federally funded projects that were programmed in the [2024 WCOG Transportation Improvement Program \(TIP\)](#).

Project obligation refers to the authorization of the use federal program funds to finance a specific project, or project’s phase. Conversely, de-obligation cancels the authorization and funding returns to the federal program source.

Projects in this listing reflect the continuous, cooperative, and comprehensive planning efforts performed by WCOG and members of the region. Regionally facilitated federal surface transportation funds are awarded through a selection process that implements the goals of the region’s long-range transportation plan: [Way to Go, Whatcom](#).

### OBLIGATIONS SUMMARY

The Whatcom region obligated nearly \$28 million dollars in 2024. The following table illustrates the federal funding obligations by jurisdiction.
